- 1. Webuild has defined its strategy and set specific targets to minimise emissions from its production processes and along the entire value chain, with particular reference to reducing CO<sub>2</sub> emissions and combating climate change.
- 6. It is everyone's right and responsibility to intervene in cases where there is a doubt that the environment may be compromised, if necessary, even confronting those responsible.

The promotion of sustainable consumption, the development of innovative solutions for environmental protection and the sustainability of the value chain are key elements for Webuild to make a tangible and lasting contribution to environmental challenges.
- 8. Experience sharing** - Webuild strongly promotes the sharing of experience between its different business units around the world in order to improve its lesson-learned approach, increase its resilience and global performance, with attention to the needs of all stakeholders in the construction phase. Webuild proposes the best sustainable solutions to its clients with the aim of enhancing the value of the work and the territory, protecting the environment and, as stated in the 'health and safety policy', to the health and safety of end users.
- 9. Dialogue** - Webuild develops and maintains stable and lasting relations with its stakeholders by paying attention to their relevant expectations and adopting appropriate forms of involvement to strengthen and consolidate environmental culture and sensitivity.
- 10. Transparency** - Webuild publishes regular environmental reports and submits relevant data and information on the performance of its Integrated Management System to stakeholders and all interested parties.
